

## Create a Bumper Sticker for God---Media Angels, Inc. (“Company”) Contest Rules

**Contestant:** To be eligible you must be living in the USA or Canada and be at least five years of age and under eighteen years of age and have the full consent of your parent or legal guardian.

**Entries:** You must agree with all contest guidelines before you submit your entry. All entries must be submitted using the Media Angels website only.

Only one submission accepted per contestant. There may be more than one contestant per household that fall into the age range stated above. Only one winner per household will be chosen. The bumper sticker slogan must be original, unpublished, and free from copyright or other intellectual copyright infringements.

**Date:** This contest is in force from November 11, 2008—December 11, 2008. All submission must be made during these dates. No submissions will be accepted after this date. Contest will be closed.

**Conditions:** All contest entries become the sole and exclusive property of the Company.
